Purpose of the In- Service Session

- **Patient Care Lapses:** Gaps or inadequacies in patient care that compromise health and safety (Newman et al., 2021).

Implement standard operating procedures and checklists.

Offer continuous education programs for healthcare professionals.

Emphasize the importance of following professional guidelines and early identification of patient deterioration.

Enhance communication channels through the use of technology for rapid information dissemination.

Introduce electronic systems for vital sign monitoring and other patient monitoring forms.

Establish a clear framework for patient and family involvement in safety procedures (WHO, 2021).

- **Continuous Learning:** Embrace ongoing training to enhance skills and stay updated with best practices.
- **Early Recognition:** Stay alert for signs of patient decline to enable prompt interventions (Murray et al., 2020).

Encouraging Skill Development and Process Understanding



Conduct realistic simulation exercises to enhance practical skills and critical thinking in patient safety scenarios.



Organize seminars that involve healthcare personnel in discussions and case studies to deepen their understanding of safety measures.



Encourage peer mentorship programs where experienced staff share knowledge and practical advice, fostering a collaborative learning environment.



Provide accessible online courses covering key aspects of the safety improvement project for self-paced learning by medical personnel (Bucknall et al., 2022).



Engage staff in scenario-based role-playing exercises to practice safety procedures, improving reaction times and decision-making skills.
